# PRESIDENT'S COLUMN

Dear Colleagues,

This is a very exciting period of time for our "helping profession." Globalization

becomes a necessity rather than a luxury. I am sure you will agree with me that ICP has been a pioneer in promoting global collaboration with our valuable work in advancing psychology and the application of its scientific findings throughout the world.

To this end it seeks to strengthen international ties between psychologists and allied professionals through deepened channels of communication and broadened opportunities for cooperative actions, especially in areas of human rights and social justice for seventy-four years.

I have appreciated the opportunity as ICP President to introduce a number of initiatives to facilitate changes toward the expansion of ICP's mission and promotion of globalization. I will highlight two of them here:

# Reduction of Membership Fee:

Globalization means that many in our profession may wish to belong to more than one professional organization. However, the potential challenge has been financial resources. In order to remove the barriers and to facilitate further collaboration with our colleagues and professionals around the world, I initiated a goal which was endorsed by the Board this year to reduce our previously variable (by country) Membership Fee to a Standard Membership Fee of \$50 (USD) and our Student Fee to \$10 (USD). ICP membership reasonably affordable and more accessible, especially for new and emerging professionals. At the same time, members who have the financial resources are invited to demonstrate their commitment and support to ICP by making a contribution and designating their donation to any of the following categories: Research & Development, Conferences/Sponsorship, or General Support or to any of the funds established by ICP, Inc.. across the years: support [Student Membership Fund; Economically Challenged Country Psychologist/Allied Professional Membership].

#### Globalization:

Another presidential goal proposed is a re-organized regional framework to support two important aspects of ICP's continued international development. One aspect is the need for decentralization and the other is connection among the various regions. Decentralization acknowledges that there are different needs and professional contributions in various parts of the world. Connection among the regions is vital and is fostered through collaborative activities, such as the international cross-cultural research that my agency, IMCES, has engaged in. Regional conferences would provide opportunities for members who may not be able to attend our annual conference.

The proposal is to divide the world into at least five regions including Europe, America (North and South), Asia (North, East, South, West), Africa, Australia, Eastern Europe and the Middle East. These regions would each have an appointed area chair/coordinator who will be responsible for providing management and coordination of regional activities. This would create opportunities for ICP to engage many academic organizations, clinics, and individual members for our organization.

Our upcoming international conference in Toronto is looking for submissions for presentations and symposia, with the possibility of future publication in a peer review arrangement. Also, there are many open leadership positions in our organization. I invite and encourage those who share ICP's mission and have a futuristic attitude to express their interest for consideration.

Looking forward to seeing you in Toronto!

# **UNITED NATIONS REPORT**



UN NGO Representative Florence L. Denmark, PhD USA

In the last newsletter I introduced you to our ICP UN interns. In addition to helping us with such projects as The International Day of Older Persons and Psychology Day at the UN, the interns attend briefings and other programs offered to NGOs at the UN. For this newsletter, our interns have written up some of the events they have covered. We hope that these brief reports will inform you about the everyday work of the UN and countries all over the world and give our interns a chance to spread the word about what they are learning at the UN.

I want to mention that Norma Simon, one of our ICP Representatives, is in charge of the interns, including selection and monitoring of their activities. Two of our interns, Lucio Forte and Evie Mitchell, attended a briefing on child labor and slavery given by Nobel laureate Kailash Satyarthi. A third synopsis refers to a meeting on autism, attended by Pancho Diaz. And last but not least, intern Alaa Alhomaizi recaps UN Secretary General Ban Ki-moon's address to the General assembly.

# Lucio Forte:

Kailash Satyarthi is a co-recipient of the 2014 Nobel Peace prize together with 17-year-old Malala Yousafzai. He is widely recognized for his decades of work at the forefront of supporting vulnerable children in the fight against child labor and child slavery.

The ILO conservatively estimates that there are currently 168 million children trapped in various forms of child labor, many of whom are enslaved, and most of whom are unable to access a basic education. Even more alarming is the fact that although this number has steadily decreased in recent years, the number of child slaves has remained unchanged at over 5 million. Data on child slavery is scarce. Satyarthi raises a call for greater interagency cooperation on this issue in order to collect better statistics that can inform policies and decisions leading to accountability.

Part of the briefing involved reflecting on the 70<sup>th</sup> anniversary of the United Nations and what needs to be done as we transition into the new SDGs and the 2015 agenda. Satyarthi emphasized that we cannot achieve many of the SDGs goals without a strong commitment to abolishing child labor. Efforts to achieve universal education, gender equality, empowerment of women, and the health of children are all challenged by the obstacles in the form of child labor practices and enslavement.

Moving forward, Satyarthi calls for three areas of action. First, a multi-stakeholder approach that incorporates governments, business, communities, local leaders, the media, and civil society is essential. Child labor practices can be entrenched by cultural norms in certain communities, but our efforts can be strengthened by a multilateral approach. Second, the time has come for a broader and deeper level of intercooperation across agencies working in this area. Various task forces have been pushing this agenda individually. We need to recognize that it is time to bring them together for a holistic response. Thirdly, the UN must be proactive in these efforts. There is a tendency to be reactive to events happening in the world, but this issue demands a proactive approach.

An important conclusion from the briefing touches on an idea that has been echoed in other talks at the UN. Attention was brought to the idea that the first line of defense against child labor is the child and his or her family. The discipline of psychology works with the family as a system within a multitude of global issues including violence-prevention, trauma, and displacement. India is witnessing a paradigm shift according to Satyarthi. Families living in poverty have started to realize that education is an avenue to empowerment and emancipation. Children are starting to demand education by raising their voices. In answer to Satyarthi's call for a multi-stakeholder approach, it seems that as psychologists we are uniquely positioned to deliver expertise, interventions, strategies, and reproducible frameworks focused on strengthening the family as part of the global effort to abolish child slavery and eliminate child labor.

#### **Evie Mitchell:**

There are many notable aspects about the internship through ICP at the United Nations which have been new to me: the bureaucracy, the organized efficiency of meetings, the broad conference rooms, and clean, bright hallways populated by impressive people (girt in all manner of expensive fabrics which serve as representation not only of their respective cultures but of a commitment to serious global progress). I have found that one of the more profound peculiarities of this internship is characterized not by the immediate experience of the United Nations itself, but rather a felt sense of a paradox-the urgency and desperation of the global human condition, tightly bound behind a thick wall of professionalism and prestige.

The DPI-NGO special briefing with Nobel Laureate Kailash Satyarthi this past March epitomized this sense for me. Kailash Satyarthi has worked for the past 20 years to fight against child labor and child slavery. Along with Malala Yousafzai, Mr. Satyarthi was awarded the Nobel Peace Prize in 2014. Although he graciously acknowledges his role in abolishing child slavery, he points out that it is far from abolished – in fact, the reported number of child slaves has been listed at 5.5 million children for over a decade, and Mr. Satyarthi believes that it has, in fact, increased with unreported cases.

Child labor has been reduced from a staggering 260 million children to a still-staggering 168 million. The SDGs have been written such that they do contain clear language regarding the abolition of child labor. However, Mr. Satyarthi points out that there is no language at all in the SDGs about the abolition of child slavery, even though eliminating such a travesty is integral to addressing the other issues cited in the SDGs, namely the issues of gender equality, poverty, and illiteracy. Children are still being abducted for trafficking - for slave labor, sex, and armed combat, all of which (it goes without saying) work actively against developing a strong social infrastructure to support progressive change. Mr. Satyarthi tells the story of a young girl, 6-7 years of age, abducted by Boko Haram and turned into a human bomb. Detonated, Boko Haram forced her to take the lives of two other people in addition to her own. Acknowledging this tragedy, he poses this question to the audience, "Can we call ourselves civilized?"

It is in this question that I felt, at that moment, the weight of this internship and the weight of every role, of every person working at the United Nations. Horrific, unfathomable trauma is being inflicted on the most vulnerable population of our species. Even as Mr. Satyarthi spoke in the ECOSOC Chamber, to people working tirelessly to abolish the trauma, the trauma still persists. During the briefing, he called for interagency cooperation and for civil society to create exemplary models which can be replicable in real world situations. It seems like a long-shot in the face of real, heartbreaking conditions. He called for unreserved indignation, accountability and action. The former is possible, but the latter?

Mr. Satyathi has spent decades standing in front of well-lit conference rooms, speaking to people dressed in expensive fabrics. But he has also spent those decades reaching out and saving individual children from lives of forced labor, abuse, trauma and other unspeakable crimes against humanity. His briefing provided an answer to the

paradox and felt sense I mentioned earlier. Caught in the tightly wound red tape of the United Nations, proposing to end child slavery by 2030 - 15 years from now – seems virtually untenable, despite the fact that the very function of the United Nations and these SDGS are to corral nations into a progressive, humanitarian future. But it is the folks like Mr. Satyarthi that keep the engine of progressive bureaucracy greased, and who put aside their professionalism and prestige and work not merely to advocate for the marginalized, but to fight on the front lines protecting and rescuing them.

# **Pancho Diaz:**

April 2nd of 2015 marked the 8th anniversary of World Autism Awareness Day, which was established by the UN, with one of the main goals as raising global awareness about autism and highlighting the need to improve the quality of life of the individuals and families affected by this disability. This year, the central theme was on employment and how about 80% of individuals on the autism spectrum remain unemployed. This provides a large untapped pool of potential talent that many companies and organizations fail to notice. Many of these autistic individuals have natural specialized traits, such as a strong attention to detail and pattern recognition, which can improve upon a company's quality of service. An employer must be able to understand these unique traits and focus on an individual's strengths rather than their weaknesses. This access to employment for autistic individuals is also a human right, and can provide these individuals with more fulfilling lives. This year, the Secretary-General's "Call to Action" invites businesses to make a commitment and employ individuals with autism.

Other themes of the day involved the advancement of scientific research on autism, and how communities around the world must collaborate together in order to gain a more global insight and understanding on the disorder. The event at the UN also celebrated many of the achievements in the global community, as ambassadors proudly showcased their programs and facilities established in their respective countries to provide for autistic individuals. Indeed, over the past decade there has been an incredible response to the awareness of autism, but as many of the panelist mentioned, there is still much work to be done to provide basic dignities for these individuals and their families.

# Alaa Alhomaizi:

On December 4, 2014 the Secretary General Ban Kimoon addressed the General assembly to inform the Member States that his Synthesis Report, "The Road to Dignity by 2030: Ending Poverty, Transforming All Lives and Protecting the Planet," is complete. However, while the report will not be released until a further date, he wanted to discuss six "Essential Elements" of the report to give the Member States a summary of the main priorities in the upcoming report. The Secretary General stated that the six essential elements of the report were dignity, people, prosperity, our planet, justice, and partnership.

The element of dignity in the report is reflected in the focus on poverty and inequality. People refers to the millions of people who still do not retain full participation in society, particularly women and children. Prosperity signifies the report's focus on the need for an inclusive, transformative global economy. Our planet is an element that advocates for our obligation to tackle climate change in order to protect our ecosystems for our children and ourselves. Justice indicates the call for fostering and creating peaceful, safe societies. Finally, the element of partnership expresses that the report and its agenda are built upon global solidarity and cooperation.

This was an important step forward in the United Nations' agenda for sustainable development. While the report and the new agenda are still forthcoming, the Secretary General's decision to address the General Assembly and provide them with a sense of the main goals of the report was a sound decision. This allowed member states to decrease their speculation regarding the new agenda and to have an idea about the targets of the report prior to its release.

The main goal of the upcoming period will be for the working group on the synthesis report to release it to the Member States and the public. Following that step, the Member States can begin discussions on the implications of the report, steps toward its implementation, as well as considerations for upcoming plans and strategies.

As you can see, we are very proud of what our interns are doing at the UN. Of course our representatives all keep busy attending meetings, working on Psychology Day, and are active in the Psychology Coalition.

# **Study Minnesota 2015 Arab States Reception**

The Arab States Reception convened on Tuesday, 24th March 2015 at the Ronald Reagan Building in Washington DC. I was extended an invitation to attend along

with Alex Schleper, the Director of International Admissions at the College of Saint Benedict and Saint John's University, which ranks first nationally among undergraduate colleges for the number of students who study abroad.

Antwaun Griffin, Deputy Assistant Secretary for US Operations at the US Department of Commerce outlined the US and Foreign Commercial Services' long standing relationship with Study Minnesota and the Minnesota Trade Office. International students are obviously a great boost to US trade interests. Higher Learning is increasingly becoming a popular service exported to other nations. This in turn sustains the American education system with regards to funding, jobs, student development and curriculum expansion. There are a greater number of countries seeking to enter into a alliance with higher education facilities in the US. One such example is Columbia. As Minister Counselor María del Pilar Fernández pointed out, Columbia has one of the highest growth rates in South America and is regarded by the World Bank as the best place in South America for investors. The Free Trade Zone has diversified export destinations, especially with principal trading partners such as the United States and the European Union. This makes cross cultural interactions between institutions a very feasible reality.

The Institute of International Education collaborates with governments, foundations and corporations on sustainable solutions to developing local education, scholarship schemes, NGO expansion and workforce training. One such collaboration was with the King Abdullah University of Science and Technology (KAUST) in Saudi Arabia, to create the next generation of leaders in the fields of science, technology and engineering. KAUST's first 368 students came from 46 countries. Through initiatives like the Scholar Rescue Fund and the Emergency Student Fund, Mark Lazar, Vice President of Global Scholarship and Learning Programs hopes to not only identify future global leaders, but to also facilitate the means by which they can achieve their goals.

With advising centers in more than 170 countries, EducationUSA teams up with local US embassies and consulates as well as partner institutions such as Fulbright, AMIDEAST and ACCELS, to assist new students worldwide in accessing US higher education. According to representatives Heidi Arola and Andy Masloski, international students comprise only 4% of the total US student body. So contrary to some views, international students are not taking seats away from potential American college applicants. "Your Five Steps to US Study" involves researching options, securing finances, completing applications, visa procedures and preparing for departure. Apart from hosting group advising sessions, individual appointments and pre departure orientations, advisors also conduct virtual advising. This applies especially to regions of internal conflict such as Yemen and Syria, where local US embassies have been closed. Advisors also help foster partner relationships between US institutions and potential local universities and schools.

Dr. Suaad Zayed Al- Oraimi, Cultural Attaché of The United Arab Emirates discussed the country's history, its rapid growth and its future ambitions. Recently, the UAE unveiled its National Innovation Strategy which would focus on seven sectors: renewable energy, transport, education, health, technology, water and space. There are Eco schools or 'green' schools being developed. The main universities are Zayed University, United Arab Emirates University, Higher Colleges of Technology, American University of Sharjah and Ajman University. With a 90% literacy rate in both Emirati men and women, there is a high demand for English language skills, mathematics, science, technology and engineering. The UAE has always believed in global cooperation and educational exchange. Along with Saudi Arabia, the UAE has the most number of students in American colleges.

Given the negative media coverage of the Middle East, never has there been a greater call to connect the USA and the Arab States. This was the essence of Mr. Fuad Sahouri's [President and CEO of Sahouri Insurance and Financial] heartfelt speech.

There is a pressing need for international students to come to the United States because they bring with them values and skills that enrich American society. Not only that, armed with a well rounded education, they can lead their homelands on a progressive curve. Congressman Keith Ellison concurred adding that although foreign students initially come to the US for education and cultural studies, they in turn become leaders of their nations, thus bridging the gap that exists between countries. They bring us closer economically, financially and intellectually which provides for greater global solidarity and stability.

Notable international alumni from Minnesota include Habib Essid (Prime Minister of Tunisia), Mohamed Benaissa (Moroccan Minister of Foreign Affairs 1999-2007), Sadek Hilal (Radiological Pioneer) and Mohannad Ghawanmeh (Filmmaker and Curator Twin Cities Arab Film Festival).

# ICP, INC TO MEET IN YOKOHAMA JAPAN IN 2016

tee Chair and former ICP, INC Treasurer, invites ICP INC MEMBERS TO VISIT YOKOHAMA IN 2016. Dr. Fukuhara is also an advisory member of committees of the International Union of Psychological Science's 2016 CONGRESS being held in Yokohama CONGRESS, July 24-28, 2016. She and her Committee, Yoshiko Kato and Edit Nagy-Tanaka, are in negotiations with hotels and congress planners to confirm the site for the ICP, INC meeting in 2016. They expect to submit a proposal with

# IN MEMORIUM Roberta M. Milgram, PhD Board Director at Large 2011-2014



Dr. Roberta Milgram and her husband Dr. Noach Milgram became members of ICP in 1975. Both remained active participants in annual conferences and leadership roles until the 2009 conference in Mexico City. Roberta remained involved, after Noach died, through her election to the Board in 2011 although

severely limited by injuries suffered in an automobile accident. Jonathan Rimon Milgram sent word that his mother Roberta died in early December 2014.

Roberta received her PhD from The American University, Washington, DC and was an associate professor in the School of Education, Tel Aviv University, Israel. She studied creativity in children and adolescents in Israel and in the US for more than 40 years and published over 50 books on the topic. Roberta developed a theoretical model in which giftedness in its various forms and at different levels is represented as being affected by home, school, and community environments, as well as by a wide variety of personality and other individual differences.

Dr. Milgram developed two measures of creativity. The Tel-Aviv Creativity Test (TACT) assesses original ideas in children and adolescents. The Tel-Aviv Activities Inventory measures genuine creative accomplishments in real world tasks. Her chapter with N. L. Livne in Kaufman & Sternberg's *The International Handbook of Creativity* (2006, Cambridge University Press) is titled: Research on Creativity in Israel: A chronicle of Theoretical and Empirical Development.

Her professional publications are many and well worth reading. Her passion and commitment to children and adolescents is evident in all of her work. See Member Publications for some of her works.

**Raymond D. Fowler** (December 22, 1930 – March 17, 2015) was an American psychologist and Professor Emeritus of the University of Alabama. He was president of the American Psychological Association (1988) and served as APA's executive vice president and chief executive officer (CEO) from 1989 to 2003.

To me Ray was a real loyal and dedicated friend. He supported me in series of ICP (International Council of Psychologists) annual conventions, before my motion on establishing an Asian psychological organization was endorsed in 2005, at an ICP convention, Fox d'Iguazu, Brasilia. He, who was then the treasurer of AAP (International Association of Applied psychology), even recommended APsyA (Asian Psychological Association) as an affiliate organization to become an ex-officio member of the Board of Directors of IAAP. Then I attended two IAAP BOD meetings, those were in its biannual conventions at Berlin (2008) and Melbourne (2010).

In 2006, the first convention of APsyA (Asian Psychological Association) was held in Bali, and Prof. Ray Fowler was one of the keynote speakers. The most important point of his speech in Bali was that Indonesia is the second country (after Brasilia) in the world where PAGE 10

psychology is most widely practiced. The truth of his statement can be seen in the fact that almost everybody in Indonesia knows about terms used in psychology such as IQ, IQ tests, counseling, personality tests, psychological assessments, etc., and that in the last few years there are more and more laws (penal, labour, child protection, gender, etc.) that contain psychology and the role of psychologist in the prevention and reinforcement aspects of the law.

# 100 Years Later: ASU Conference on Ottoman Turkish Genocide of Armenians

On 21-22 March 2015, over 250 academicians, scholars, students of law and humanities gathered at the Arizona State University Law School to Commemorate the Centennial of the Ottoman Turkish Genocide of Armenians and other Christian minorities. According to the Center for Holocaust and Genocide Studies (U. Minn), census figures show that there were 2,133,190 Armenians in the Ottoman Empire in 1914. By the end of 1922, that number had been reduced to 387,800.

Dr. Kalayjian was invited to bring a unique perspective to the conference. She was invited to address healing perspective through acknowledgment, forgiveness, transforming generational trauma, and much more. Her presentation was very powerful, dynamic, interactive, and filled the audience with thoughtful but non-traditional reflections. She presented on horizontal violence, generational transmission, and how to heal and be empowered. She revised an anonymous quote and said, "Trauma and pain that is not transformed will be transferred to seven generations" and described the findings of her research indicating how the trauma of Genocide had passed already through two generations.

A rich reception followed each day of events and panel discussions. During Q&A session most were eager to learn how to forgive, why to forgive, when to forgive, and how to empower the next generations.

The mellow mushroom is not only photo, it is a symbol of an informal, humorous "study" I conducted in each country and place I went where ICP, Inc. met: I go to a local pizza place to see how their pizza is similar to or different from the others.

Summer, fall, winter and spring annual cycles are controlled by and vary according to the geographic hemisphere. ICP, Inc.'s cycle for producing the *International Psychologist (IP)* follows ICP'S annual functions. July / August is the calendar time for ICP's face to face gathering, the association's annual highlight and primary activity. The two *IP*s before July/August are what educators would call "readiness" issues. They focus on providing information about the upcoming conference and board meeting: Location, registration, proposals and hotels. A second highlight of the first part of the calendar year is ICP's annual election for board members.

This year the **Board election ballot should be** emailed to members in late May. That should allow a minimal 30 days up to 45 days for voting. When possible, candidates are introduced in newsletters. A preview outline of the scientific program is included in a newsletter before the conference.

Abstracts of presentations are compiled into the scientific program book prepared by the President Elect and Annual Conference Committee. All leaders, elected and appointed, provide annual reports to the President and Board about their activities on behalf of ICP, Inc. since the last conference. These reports and recommendations to the Board are included in the **Board Agenda Book** prepared by the current President.

The second two issues of the *IP* serve to follow-up on the July/August event and to set the stage for the calendar year ahead: photos, reports, dues collections, calls for nominations for the next year: awards; board positions; for appointed positions; and volunteers to assist with the Incoming President's initiatives.

Each issue aspires to present a column and report

from each member of the executive committee and Directors at Large are urged to send reports as frequently as possible, and no less than twice a year. That <u>executive</u> <u>section</u> is followed by Member News, International News and Administrative information.

<u>Member News</u> and <u>International News</u> is enlivened by your submissions. Please be sure to send in your recent publications, awards/recognitions/certifications and participation in international activities. The <u>Administrative</u> section wraps up the newsletter and provides membership application forms, conference registration forms, announcements leadership contact information and the messages from the Editor and Banking & Records Manager.

The *IP* **Part B**: *International Understanding* is compiled twice a year. This is an informal journal publication. Those who are new in the publishing arena or writing in their second language are especially encouraged to submit manuscripts to the IP editor.

The *IP* recently received a number of commendations from members and friends of ICP, Inc. This is encouraging. Both Nancy Quatrano, who does the format composition and frequently a lot of proofreading-editing, and I, send our appreciation to those who give time to serve on the Editorial Review Panel, to those who provide substantive content and to those who read and enjoy the *IP*. The *IP* is essentially the backbone of the association and keeps the cycle of association life moving. Each *IP* is sent directly to members and friends. IP can also be found on the association website: <u>ICPWEB.ORG</u>

Hope to see you at the Toronto conference and board meetings, which are open to members.

# BANKING AND RECORDS MANAGEMENT



#### May 2015

#### Ms. Nancy L. Quatrano, USA

*Hastings, Florida.* The ICP, Inc. net worth is stable as of April 30, 2015:

- The PayPal account balance is \$2661 and is comprised of both membership dues and conference registrations. Still outstanding is \$1264 of invoiced fees which belong to the operations account for conference expense reimbursements from 2014. Invoicing membership dues directly from the PayPal account has been successful (65) and some members have indicated that this worked well for them. Doing it this way enabled many to simply hit the PAY NOW button and then input their payment information. A receipt is generated from the system to the payor, immediately. We have had a couple of hiccups, however. I continue to work on those. (Outside USA.)
- The convention account balance remains at \$2537. I will transfer funds into the operations account at the conclusion of the convention.
- The operations account balance is \$21,693. All accounts payables to the UN, liaison organizations, and members for ICP expenditures have been paid. We will have more conference related expenses in the next quarter. Some reimbursement from the convention account will occur in the fall.
- The escrow (awards/reserve) account balance is at \$59623. I transferred \$600 into the operations account on behalf of the Fukuhara Award fund payments for the 2013 and 2014 award payments. Interest remains minimal at approximately \$2.47 per month.

All corporate and US IRS filings are up to date. The CPA filed the 1099 for contractor fees paid in 2014, and filed our tax-exempt IRS report on March 19, 2015. I continue to support membership work which needs more attention than I have time to give it, but when time permits, I send out dues reminders to those still unpaid. We've had several members pay current and back dues now that on-

line payment has been streamlined and it's wonderful to welcome them back into active status! In total we have 70 paid in full members (all regions) with 37 unpaid 2nd call invoices still in the system. I'm also updating email lists as I receive verifiable information and requests.

I'll compile and create a more detailed membership report for the annual meeting which I plan to attend this year at long last.

I've been busy along with the 2015 Conference Committee with forms and arrangements for the 74th Annual Conference in Toronto. There are so many of you I look forward to meeting while there.

# GUIDELINES FOR HOSTING AN INTERNATIONAL COUNCIL OF PSYCHOLOGY ANNUAL CONFER-ENCE AND BOARD MEETING

The International Council of Psychology, Inc holds an annual scientific program and Board meeting each year in accord with the policy of freedom of movement of scientists. The conference host (local arrangements committee) must be a member of ICP,Inc. To establish the feasibility of submitting an application, a potential applicant might begin with an overview of some logistical issues for proposing a Congress venue:

- Is there a conference venue to host at least 100 participants? (50)? (30)?
- Are there sufficient hotel rooms close to the conference venue
- Is there a scientific community to develop or sponsor the program?

**Proximity in time and site to other major professional congresses.** ICP operates in alliance with the International Association of Applied Psychology [IAAP, quadrennial congresses], the International Union of Psychological Science [IUPsyS, quadrennial congresses that meet in between the IAAP cycles]; the American Psychological Association or the Canadian Psychological Association; with options for meeting near allied professional association on intervening years.

**Proximity in time and site to other major professional congresses.** ICP operates in alliance with the International Association of Applied Psychology [IAAP, quadrennial congresses], the International Union of Psychological Science [IUPsyS, quadrennial congresses that meet in between the IAAP cycles]; the American Psychological Association or the Canadian Psychological Association; with options for meeting near allied professional association on intervening years.

**Geographical Rotation** among continents and countries attempts to guarantee broad geographical coverage, proximity to other major professional conferences, or in regions where psychologists may not have presented a scientific program previously.

The scientific community in the conference country is especially invited to participate in the scientific program.

**Communication**: There is a requirement for intensive and frequent communication between the Board President, Scientific Program Chair, Local Arrangements Chair, Workshops Chair, InAbsentia Student Posters Chair, and Awards Chairs.

**Costs** for participating in the Congress are another factor. The Board will expect that the registration fee will be reasonable, that there is a range of good hotel rates (particularly including inexpensive ones), and that travel costs can be kept as low as possible. Despite efforts to keep costs low, travel is expensive for **young psychologists**, and for psychologists from the **developing world and transition countries**. It is therefore important to provide a plan that will guarantee special fees, housing, and support for those colleagues.

A **balanced budget** needs to be provided in outline. It is important to show realistically how the income (registration fees and other) will cover your costs. It may be helpful to consult the preceding organisers of Conferences in drafting the budget. The budget is reviewed by the President and the Treasurer, who can offer advice.
