May is National Mental Health Awareness Month in the United States. Many activities were designed and implemented to raise awareness and reduce stigma as it relates to mental illness. IMCES and ICP dual members conducted considerable activities both locally in Los Angeles and nationally in the United States to address mental health disparity. The activities ranged from workshops and public education seminars around many topics related to encouraging behavior that builds wellness and emotional resiliency to conducting the Stigma Survey in the context of culture; recognizing depression as a major health hazard; engaging professionals around the world to be engaged in international cross-cultural research; and participating in advocacy projects to promote health and mental health and access to resources for underserved population.

The global research has been very well received. In fact, we have been approached by scholars from different parts of the world proposing to travel to Los Angeles for the purpose of engaging in study and collaborative research. Such positive responses as these are encouraging, as they are indicative of the kind of collaborative projects and relationships between ICP and universities and mental health clinics throughout the world that, as President, I wish to foster.

In addition, I am making preparations for a presentation at the 65th Annual United Nations DPI/NGO Conference in New York (August 27-29). This would be an invitation to our international member to contact me with their interest in participating in that presentation.

I am also looking forward to our ICP conference in Paris this year (July 13-15) in collaboration with the 28th International Congress of Applied Psychology conference (July 8-13). I would like to see all of our members in Paris for this opportunity to meet, share, and renew our commitment to our ICP mission in the world.

Our ICP family grows smaller but stronger. We have much to give the World and let us hope that the World and those in conflict will use our strengths and skills to create a World which is better than the current one for our children's sake and those of our grandchildren.

I am delighted to announce that the ICP's biggest event of the year—the 72nd Annual ICP Conference 2014—is less than two months away, to be held in Paris from July 13 to July 15. Hyatt Regency Etiole is the head-quarter hotel which is home to all conference activities—including keynote address, paper and poster sessions, in absentia poster exhibit, board meetings, receptions, and social events. The scientific theme of the 2014 conference is “International Perspectives on Global Issues;” and the invited keynote speaker is Professor José María Peiró, President of the International Association of Applied Psychology (IAAP) and Professor of Social Psychology at the Universitat de València.

Apart from scientific sessions, there will also be award presentation ceremonies that recognize the outstanding achievement of scholars, including the Frances Mullen Award for recognizing the distinguished contributions and service of an ICP member, the Seisoh Suke-mune/Bruce Bain Award for recognizing the outstanding research achievement of an early-career psychologist, the Fukuhara Advanced International Psychology Research and Service Award for recognizing the distinguished contributions of a mid-career or senior-level psychologist to international psychology, and the Denmark-Grunwald Award for recognizing outstanding research and service to feminist research. We would like to sincerely thank for the hard work of the 2014 conference coordinating committee, chaired by President-Elect Dr. Janet Sigal, for making this important event happen.

Besides the ICP Symposium has been scheduled on July 13, the last day of another major event—the 28th International Congress of Applied Psychology. This ICP Quadrennial ICAP Symposium is scheduled on the last afternoon of ICAP 2014 to celebrate the long standing alliance between these two of the three senior international associations of psychologists. More importantly, both events are held in Paris is especially meaningful, given that the first international congress was held in the same location back in 1889 and ICP's first European President was Dr. Lisette Fançon, Director of the Wechsler Laboratory of the Université Paris Descartes. Also, there are many long time ICP members who are

also IAAP members. Their current president, Professor José Peiró, received the 2013 ICP Fukuhara Advanced International Psychology Research and Service Award in recognition of his advanced research and service in international psychology.

Lastly, the ICP requested registration for the 23rd session of the Commission on Crime Prevention and Criminal Justice (CCPCJ). ICP's main representative in Vienna, Austria, Dr. Roswith Roth of Graz, will be representing our organization and partaking in a discussion about cyber mobbing in a side event of the Committee on the Status of Women in the framework of the CCPCJ in May 2014.

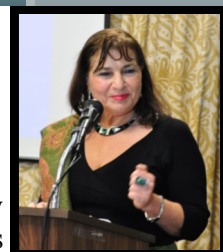

UNITED NATIONS REPORT

In January 2014, I joined the Committee on the Status of Women, at the UN in Vienna.

I attended 4 meetings: 16 January, 2014, 20 February, 2014, 3 March, 2014 and April 24, 2014, in the framework of the CCPCJ. I was invited to hold a talk about the psychological aspects of *cyber bullying*.

One of our members attended the 6th Human Rights Summit sponsored by UN Watch and an NGO coalition was held in Geneva on February 25th, 2014. The goals of that summit which is held once a year, is to give a floor to discussion of violations of human rights across the *entire world* by strengthening those victims of human rights abuses that did not get enough attention at the Council of Human Rights meeting in Geneva.

The meetings at the UN in Vienna focused, among other issues, on the 23rd Session of the Commission on Crime Prevention and Criminal Justice (CCPCJ). The CCPCJ Conference took place at the UN in Vienna, 12 May- 16 May, 2014.

The Committee on the Status of Women organized two side events in the framework of CCPCJ:

(Production Editor's Note: At time of report submission, this June meeting had not yet been held.)

The next meetings on 5 June, 2014 will deal with the forthcoming UN Convention against Corruption. The Vienna NGO committee on the Status of Women will also cooperate with the UN in Geneva preparing the Geneva NGO Forum – Beijing + 20, UN ECE Regional Review, 3 -5 November, 2014 in Geneva, Switzerland.

Three aspects are in the focus:

To contribute to the Beijing +20 review process, both at the ECE regional level and globally

To identify emerging women's issues in the global world
To provide input for the current discussions on the Post---2015 Agenda

Additionally, the NGO Forum aims to **create a space for open dialogue among NGOs, civil society and other stakeholders** from the 56 ECE member countries on the realities impacting women in this diverse region.

An E-Discussion on Addressing Challenges for Meeting the MDGs and Sustaining Development Gains took place at the UN in Geneva February 3 - March 16, 2014. This e-discussion aimed to engage experts, policymakers, practitioners and other stakeholders in a global dialogue on the UN Economic and Social Council (ECOSOC) Annual Ministerial Review's (AMR) 2014 theme, 'Addressing ongoing and emerging challenges for meeting the Millennium Development Goals (MDGs) in 2015 and for sustaining development gains in the future'. The e-discussion is expected to provide ECOSOC with inputs and policy recommendations on strengthening efforts to achieving the MDGs by 2015 and on sustaining and continuing development gains in the context of the post-2015 development agenda. The e-discussion is divided into three parts. Part I (3-16 February) focused on 'Facilitators of development progress, including in the achievement of MDGs'. Part II (17 February-2 March) addressed 'Sustaining development gains through inclusive development'. Part III (3-16 March) will discuss 'Measuring progress in MDG achievement and beyond'. Contributions are expected to contribute to the UN Secretary-General's report on the AMR theme, regional preparatory meetings and the National Voluntary Presentations. The UN Department of Economic and Social Affairs (DESA) and the UN Development Programme (UNDP) have held annual e-discussions on the respective AMR themes since 2008.

The aim of the Policy Dialogue of the Sustainable Development Goals (SDGs) is to evaluate the progress made in the definition of SDGs and to discuss the difficulties and opportunities to set up a common, universal, agenda in order to address and monitor global challenges. High-level Panel of Eminent Persons, as well as the outcomes of the four sessions of the Open Working Group on SDGs conducted in the first half of 2013 illustrated the complexity of this complex process. The United Nations Conference on Sustainable Development (UNCSD), also known as Rio 2012, Rio+20 was the third international conference on sustainable development aimed at reconciling the economic and environmental goals of the global community. The ten day mega-summit, which culminated in a three-day high-level UN conference, was organized by the United Nations Department of Economic and Social Affairs and included participation from 192 UN

member states — including 57 Heads of State and 31 Heads of Government, private sector companies, NGOs and other groups. It was intended to be a high-level conference, including heads of state and government or other representatives and resulting in a focused political document designed to shape global environmental policy. The 68th session of the UN General Assembly that started in September 2013 will be an important milestone in the definition of Sustainable Development Goals (SDGs), following the outcomes of Rio+20 and in the framework of the Post-2015 Development Agenda.

Satir Model Family Psychology & Therapy Training Programme: Toward Healthy Families 2020 is unique in encompassing both the intrapsychic and interactive components of therapy. Much therapy of the past has been focussed only on clients' behaviour, cognition, or affect. This model is focussed on bringing about positive change at the level of existence, as well as changes in doing, feeling, and perceiving. The process taps the universal yearnings of individuals within their personal family and social systems and helps them work towards a sense of responsible wholeness. The process requires that the therapist has a high level of therapeutic competence and congruence.

Participants will also work with their own three generational family of origin maps, to increase personal learning opportunities in applying this systemic therapy model.

IAAP LIAISON

Liaison to the International Association of Applied Psychology

The ICP, Inc. alliance with the International Association of Applied Psychology (IAAP) and the International Union of Psychological Science (IUPsyS) began the first years that ICP held annual conferences and continues today. Initially, in order to become a member of ICP an applicant had to be a member of a national association that was a member of IUPsyS. Only national associations were members of IUPsyS, but IAAP was open to individual membership, like ICP is, but was focused on applied and work psychology rather than clinical, experimental or educational.

While ICP has been pleased to be inclusive, with members from all branches of psychology and to offer annual scientific conferences that provide a forum for presentations from the full range of psychologists, IAAP and IUPsyS hold quadrennial congress. The long standing agreement has been that ICP will meet near the quadrennial congresses and that "member" registration is offered to members of the other associations.

IAAP's 28th Congress is being held in Paris, France and is a primary reason that ICP is meeting in Paris for two days following the close of the July 8-13 ICAP2014. The Honorary Chair of the Paris 28TH Congress is Claude Levy Leboyer who was the keynote speaker for the ICP Annual Conference and Meeting in Tel Aviv in 1986. She is one of the first women leaders in work [industrial / organizational / consulting] psychology and was President of IAAP in the 1980s. The President of this Paris congress is Dr. Christine Rolland-Levy who has graciously assisted with arrangements and announcements regarding the ICP, Inc. 72nd annual meeting.

Dr. José Maria Peiró is the IAAP President and received the ICP 2013 Fukuhara Award for Advanced

International Research and Service. As a colleague-friend of ICP former president Charles D. Spielberger, who was the 25th IAAP president and died last summer, Dr. Peiró collaborated with myself and Dr. Thomas Brunner to prepare the obituary for "Charlie" that appeared in the March issue of *The American Psychologist*. A tribute to Dr. Spielberger will take place during the ICAP2014 Congress.

Another former President of IAAP, Ray Fowler, who was co-chair liaison between IAAP and ICP, suffered a stroke following the 27TH ICAP in 2010, Melbourne, Australia. He has not been able to complete his tenure as president of IAAP due to health complications following that stroke. His wife, Sandy, reports that although he is not able to communicate well, he wants to attend the APA convention this summer in Washington, DC, where he served as CEO of APA for many years, initiating the annual "rats race" run that is held at those conventions.

It is disappointing that I am unable to attend the Paris conference, but was fortunate to be able to organize the invited symposium. It will be a panel of former ICP presidents addressing how ICP contributes to the Congress theme, "From Crisis to Sustainable Well-Being" through educational programs, UN NGO work to assist women, children and the elderly, and to provide a forum for face to face exchanges of information and collaborations between psychologists -- and now including allied health professionals. That panel is scheduled for Sunday July 13 from 2 until 4 pm. Immediately following that session is the ICAP closing reception by the hosts for the 2018 congress, and following that, in the Hyatt Regency Etoile, is the opening welcome session of the ICP 72nd Annual Program.

Psychology debuts at an historic Congress in Armenia

On 17-19 October 2013, 300 scholars from 20 nations converged on the majestic National Academy of Sciences building in Yerevan, Armenia, for the historic "Second International Congress on Armenian Studies." Two ICP members--Ani Kalayjian and Harold Takooshian--were among the experts who met for three days of intensive discussions on the past, present, and future of Armenian Studies. Participants at all levels joined in this dialog: government officials, leading experts, new scholars, and students.

History was made at this conference by the noted scientist **Gevork Poghosyan**, Director of the Academy's Institute of Philosophy, Sociology and Law, who added a new panel to the Congress on "Behavioral science and Armenian studies today." In his passionate message, Dr. Poghosyan noted *"Yes, we Armenians have a remarkably rich history dating back to ancient times, but Armenian Studies is also today. We can and must engage scientists to use their statistics and modern techniques to study issues that face the Armenian diaspora and Republic in 2013--identity, migration, community stress and well-being, village and urban life."*

Poghosyan's behavioral science panel included 8 scientists from four nations: USA, Russia, Germany, and Armenia. (1) Sociologist **Edward Tiryakian** of Duke University prepared a report on "New avenues for Armenia's development." (2) Psychologist **Harold Takooshian** from Fordham University presented his survey data on "Ethnic identity among Armenian-American behavioral scientists." (3) Psychotherapists **Ani Kalayjian** and **Katherine Kaze** of www.MeaningfulWorld.com presented their work on "The 7-step integrative healing model" to reduce horizontal violence among Armenians and others. (4) Psychologist **Iren Yeresyan** of the Universität Bielefeld offered her findings on "Stress and well-being of Armenian youth in Turkey and Germany." (5) Psychologists **Meline Karakashian** and **Maria Tevosyan** of Abovyan Pedagogical University reviewed "The state of psychological practice in the Republic of Armenia." (6) Historian **Azat Khasanov** of Saint Petersburg State University presented his archival data on "Armenian-Swiss relations."

While in Yerevan, many in this panel of experts also participated in other activities. Dr. Kalayjian's team met with several officials, and offered a workshop for Syrian refugees in an Armenian village. Other groups spoke at

Abovyan University about US-Armenian cooperation, or at the Ministry of the Diaspora. Some of these scientists are involved with the Armenian Behavioral Science Association (ABSA), a world-wide association of 600 scientists, formed in 1987 to promote behavioral science in the Armenian community. Healing Trauma of Domestic Violence Around the World Symposium at 58th Session of the UN Commission on the Status of Women

New York, NY, 20 March 2014 – In conjunction with the 58th Session of the United Nations Commission on the Status of Women, ATOP Meaningfulworld presented a symposium on “Healing the Trauma of Domestic Violence Around the Globe” at 777 UN Plaza.

The objectives of this symposium were: 1) to present data on the ongoing prevalence of domestic violence throughout the world, particularly as it affects the most vulnerable groups and intersects with other global conflicts and traumas; 2) identify promising new psycho-spiritual approaches to healing the trauma of domestic violence and reinforce the value of integrative methods; 3) discuss the intergenerational inheritance of unresolved trauma; and 4) provide an experiential demonstration of one such healing method.

Following welcoming remarks by Blerina Marku, ATOP Meaningfulworld public relations coordinator, Dr. Ani Kalayjian, founder and CEO, shared an overview of women’s empowerment and healing initiatives spearheaded by ATOP Meaningfulworld in 45 countries around the world. She concluded by saying, “The human race is like a bird with two wings, one male and the other female. If we are not mindful and make sure the right and left wings are coordinated and harmonious, the human race cannot move forward and prosper.” Thereafter, in the therapeutic ambiance of candles, literature, and poignant testimonials on the trauma of domestic violence, experts offered insight on coping strategies leading to healing and transformation.

Rev. Dr. Victoria Jeanne Rollins, founder of the LOVE Task Force on Nonviolent Living, New York, NY, gave a presentation on “Reclaiming Life: Love’s Transformative Power to Heal the Wounds of Trauma.” She defined LOVE as an action verb that, combined with the mindful choice to recognize, honor, and nurture the divine spirit within, allows us to transform, to heal ourselves and others. Overcoming fear of pain, hurt and denial are primary challenges in the process of healing and preventing further physical, social, spiritual, emotional, sexual, and economic violence.

From Dr. Donna Goetz: 2014 Graduation Ceremony

Dear Graduates,

After all your hard work, you have accomplished something you can be proud of. I offer you congratulations along with all our faculty members. You have achieved one of your goals. You will have many future opportunities and you will be able to make opportunities for yourself. You can contribute to making this world a better place.

Two of my personal goals are to continue learning and to travel to many countries. To reach these goals, I developed a travel-study course to take students to meet psychologists in Germany and Austria to learn about their work.... I emailed German psychologists who had written interesting articles, to see if I could visit them with students. I assigned my favorite book, Dr. Victor Frankl's book, *Man's Search for Meaning*, to the course syllabus. Frankl wrote that it is our responsibility as humans to create a meaning for our life.

And that is my challenge to you today. What will you decide to do to create meaning for your life?

Dr. Frankl was a young Jewish psychiatrist during the time of the Holocaust. He, his wife, and his parents were forced into concentration camps by the Nazis. When he was arrested, the manuscript of a book he had just written, was taken from him and destroyed.

While in the camp, he observed the other prisoners and noticed that those who gave up hope died within a few weeks. The men who gave up hope died within a few weeks. The men who survived had something to live for. His two goals were to live to see his wife again and to rewrite his book.... His wife and parents were killed in the camps. Frankl survived, and after the war, [he] became a famous author and remarried. Frankl used his intellect to confront evil in the world. He developed a system of therapy to help his patients find meaning in their lives.

When my students and I were in Graz, Austria, the receptionist at our hotel asked why I had brought a group of American students to Austria. I explained that we were visiting psychologists to learn about their work and we were also learning about German culture. When I mentioned Dr. Frankl, she became excited and said, "Every time he gave a lecture here in Graz, he would sit at that table and have a coffee before his lecture. I am so happy that American students are learning about Frankl's work. I will bring you two books which he gave me and he autographed and drew a caricature of himself in one of them." When she gave me the books I told her that I would show my students, and take good care of the books and return them.

"Oh no, they are a gift to you."

Our group then took the train northeast to Vienna. My class and I met with Mr. Harold Mori, who had been Frankl's assistant. He showed us where Frankl had lived before he was imprisoned. We had lunch and discussed the book with him.

Then, Mr. Mori said, "I have a surprise for you. Mrs. Elly Frankl, will receive you in her apartment today."

Mrs. Frankl showed us a room filled with awards and photos taken of her late husband and her with Presidents Eisenhower, and Kennedy and more. Several photos showed him with various popes.... Near the end of our visit, I showed her the books that the receptionist had given to me. She asked if she could keep the one with his caricature.

She said, "I had often sat next to him and watched him draw that but I do not have a copy for myself."

When I designed my course, I had no idea that my students and I would be able to meet Mrs. Frankl or that I would be able to give her something in return. All those hours of studying German grammar and planning our trip led to a marvelous moment.

So, today, Graduates, I urge you to pursue your own goals and dreams. Your faculty and I treasure you and hope that you will find your own treasures and discover the deep meaning in the purpose of your life.

Personal details

Born on 7 October 1936 with an early childhood spent on a sheep station in far western Queensland (the Outback) where the way of life, impacted by drought, flood and periodic economic hardship when market prices fell, was sustained by the values of hard work, skill, ingenuity, resilience, mateship, loyalty and humour. In addition, and on account of the location's remoteness, a huge importance was attached to what was practical because, if it was not, the consequences were dire.

Education

Gained a Queensland Diploma in Animal Husbandry from Gatton Agricultural College (1956). Studied for an Arts degree at the University of Queensland with the intent of obtaining a general education before undertaking a jackerooing apprenticeship. Enrolled by chance in psychology where, halfway through the degree, a few lectures in industrial psychology led to a decision to transfer to the Faculty of Commerce in order to study subjects which were the language of business, such as accounting and economics. Graduated with a B.Comm. [Hons in psychology] (1961) and then an M.Comm. (1965) as an external student.

Extra-curricular activities included University Rugby XV, Queensland Rugby XV, residential College President, Psychology Students Association President.

Graduated with a Ph.D. (1968) while a Faculty member in the Department of Business Studies at Edinburgh University.

Was privileged to become a Visiting Scholar at the Sloan School of Management of the Massachusetts Institute of Technology (1975) and at the Social Systems Science Centre in the Wharton School of the University of Pennsylvania (1979).

Military Service

Compulsory military service was served part-time in the Army Reserve in three different Units over ten years; 25th Infantry Battalion (promoted Sergeant); Queensland Uni-

versity Regiment (promoted Lieutenant); 2 Commando (promoted Captain).

Career Path

- ◆ [Early] Edinburgh years could not have been better; a Department whose Faculty were dedicated to teaching, a University with an historic reputation, a charming city, Scotland as a country with a proud history, and the Scots as an admirable people. The research side essentially involved the analysis of organizations as social as well as economic entities. This was heavily influenced by the treasure troves of deep institutional learning possessed by the Department of Labour, Edinburgh University, the Massachusetts Institute of Technology, and the University of Pennsylvania. This phase of approximately a decade led to the publication of a research monograph: *Organizational functioning: a behavioural analysis*. Farnborough, UK: Gower Press, 1980. Textbook: *Organizational Behaviour: Changing Concepts and Applications*. Sydney: Harper and Row, 1990).
- ◆ All this was brought to an end only by an offer to join the Faculty of Business and Economics at Monash University which was setting up its own MBA degree. The length of the Monash period is a tribute to the University (1970 – present) and falls into four phases. The first phase of approximately a decade focused essentially upon teaching and research. On the teaching front the new MBA program provided the opportunity to introduce the first courses in Australia in two areas, organizational behaviour and human resource management. It also afforded the means to introduce advanced experiential learning techniques such as process analysis and organizational analysis which had a profound effect not only on student interest and enthusiasm but also on the internalisation of knowledge and understanding and their integration into the students' everyday working and private lives.
- ◆ The second phase arose out of realising that, because much of what was taught in Business Schools nationally was derivative and based upon overseas research, what was needed was to combine the best of mainstream international knowledge with content which reflected local attitudes, values and practices. To achieve this was a long-term project that resulted in the publication of the first textbook on organizational behaviour that was not an adaption of an overseas textbook (*Organizational Behaviour: Changing Concepts and Applications*. Sydney: Harper and Row, 1990).
- ◆ The third phase centred upon administration when appointed as the Director of the Monash MBA program. This entailed developing the behavioural side of the

program in addition to its financial and statistical strengths, especially through the introduction of subjects such as planned change and management skills (essentially leadership development). It also resulted in taking the MBA to be both the largest and highest ranked MBA in the nation as well as the largest graduate program across all Australian universities.

- ♦ The fourth and last phase was in many ways an extension of the third. Thus, rather than fostering the development mainstream applied psychology in Australia, its aim was to encourage, facilitate and support its growth in other regions of the world, especially to countries with developing economies. This is dealt with further in the following section.

Scientific and Professional Societies and Associations

- ♦ [Initially] introduced to the realm of international psychology through three main events; the 1978 International Congress of Applied Psychology (Munich), the 1980 Conference of the Chinese Psychological Society (Beijing) [the second conference after the Cultural Revolution after a lapse of approximately two decades], and the Sydney ICP in 1988.
- ♦ Elected onto the Board of Directors (BOD) of the International Association of Applied Psychology (IAAP) in 1986. Was appointed the founding Editor of the Association's *Newsletter* (later *Bulletin*) in 1988.
- ♦ Was elected as Secretary General (1990-1998) [the first Australian to be appointed to this position and as a result to being a member of the IAAP's Executive Committee].
- ♦ Elected as President (2006-2010) [also the first Australian to be appointed to this post]. [One goal was:] developing the closest cooperation with other major international organizations of psychology.
- ♦ These included the International Union of Psychological Science (IUPsyS), the International Association of Cross-Cultural Psychology (IACCP), and the International Council of Psychologists (ICP). Also equally included were regional associations of psychology such as the European Federation of Psychologists Associations (EFPA), the Sociedad Interamericana de Psicología (SIP – the Interamerican Society of Psychology), and the Pan African Psychology Association (PAPU – in formation).

Dr. Sabine Szcesny is a Professor of social psychology on the faculty of the University of Bern, Switzerland. She is the author or co-author of over 38

articles in peer-reviewed journals and countless book chapters.

She is author of a book on sexual harassment. She and Lisa von Stockhausen received a large grant from EU Research, titled the *Marie Curie Action Project*.

Dr. Szcesny is the coordinator of the project's research which includes researchers across several languages, cultures and countries. Their goal is to decipher how "certain features of languages and language use influence gender equality in societies, social behavior towards the sexes, and how gender equality can be promoted through gender-fair language use."

Dr. Szcesny's work is widely cited by other researchers and ICP has chosen her to accept the Denmark-Grunewald Award for Gender Research for 2014.

GUIDELINES FOR HOSTING AN INTERNATIONAL COUNCIL OF PSYCHOLOGY ANNUAL CONFERENCE AND BOARD MEETING

The International Council of Psychology, Inc. holds an annual scientific program and Board meeting each year. The conference host (local arrangements committee, coalition or proposal agents) must be a member of ICP, Inc. To establish the feasibility of submitting an application, a potential applicant might begin with an overview of some logistical issues for proposing a Congress venue:

Is there a conference venue to host at least 100 participants?

Are there sufficient hotel rooms close to the conference venue

Is there a scientific community to develop or sponsor the program?

How are Countries Selected?

If you believe your country/city/university would be appropriate for hosting an International Council of Psychology annual meeting, you may wish to submit an application. It is the ICP, Inc. Board of Directors that votes for the selection. Although it is hard to predict just what features of a proposal define the voting outcome, the Board typically takes the following items into account (the order of the items which are listed here is not necessarily in the order of importance):

Geographical Rotation among continents and countries attempts to guarantee broad geographical coverage, proximity to other major professional conferences, or in regions where psychologists may not have presented a scientific program previously.

The scientific community in the conference country is especially invited to participate in the scientific program.

Communication: There is a requirement for intensive and frequent communication between the Board President, Scientific Program Chair, Local Arrangements Chair, Workshops Chair, InAbsentia Student Posters Chair, and Awards Chairs.

Costs for participating in the Congress are another factor. The Board will expect that the registration fee will be reasonable, that there is a range of good hotel rates

(particularly including inexpensive ones), and that travel costs can be kept as low as possible.

Despite efforts to keep costs low, travel is expensive for **young psychologists**, and for psychologists from the **developing world and transition countries**. It is therefore important to provide a plan that will guarantee special fees, housing, and support for those colleagues. This plan should be clearly outlined in the budget, including special provisions for ARTS programmes (by agreement, at least 30 ARTS participants are provided registration waivers).

A **balanced budget** needs to be provided in outline. It is important to show realistically how the income (registration fees and other) will cover your costs. It may be helpful to consult the preceding organisers of Conferences in drafting the budget. The budget is reviewed by the President and the Treasurer, who can offer advice.

The International Congresses of Psychology adhere to the **ICSU principles of free circulation of scientists**. Provide evidence that any scientist, from whatever country, will be allowed to enter your country without special requirements (except for the regular passport and visa). Based on former bids, it is a good idea to include an official letter from your country's government, stating explicitly that your country adheres to the ICSU principles of free circulation of scientists

Submit a letter of intent to the Long Range Conference Planning Chair.

The finalized application file should be forwarded to LRCP Chair, ICP, Inc., President and Treasurer **several months ahead of the Conference meeting date**.
