Six Month Report from Your Secretariat General

Dear ICP Colleagues,

Today, January 13th is the first day of the Russian New Year. Tomorrow, our university classes begin again in Maine. The Spring semester is starting. I'm anticipating more than a foot of snow will fall, adding to the white carpet that's already marked the season. Even with global warming, winter here is unfolding peacefully. Writing to you, my thoughts are focused on our meeting in Saint Petersburg six months from now. At the half way point of the year, It's time to provide you with an 'interim report' from your Secretariat General office. If I've made this report too "dry" for you, it's my first submission to IP. I welcome your critique or suggestions for future reports.

First let me say, I hope that many of you as can make the trip, will join us. The heart of ICP are those enduring relationships that we have. Our meeting is scheduled after the International Conference on Teaching Psychology and before the International Congress of Psychology. It promises to be a good mix of Russian culture, renewing of friendships (and making of new ones), learning and continuing the work of positioning ICP for the years ahead.

I actually began thinking about this report last July in San Diego. At the end of the Board's work, I accepted the challenge of re-developing for you, the role of the Secretariat-General. Having served in the Board for three years, I knew what a great challenge lays before us, both collectively and individually. And, as a member of long standing, I treasured our distinguished history and the remarkable accomplishments of ICP since its founding in 1941. I knew too that ICP is an organization whose uniqueness has been embodied by a cadre of pioneering women in psychology worldwide. Given these factors, I confess that I was considerably unnerved.

I accepted this challenge, because of the amazing support I have received from members, particularly those serving on the Board. I was encouraged as well by an earlier meeting in Kos (2006). There I had the great pleasure of meeting Drs. Ray Fowler and Bernard Wilpert as well as Ms Sarah Oates from Blackwell. These leaders and facilitators I admire. Their dedication to international psychology continues to energize me. They affirmed that global psychology was undergoing rapid transformation. But, their angst was less than my own. They had an excellent perspective and valued highly ICP. They understood well ICP unique traditions of friendship and collaboration. Nevertheless, last July in San Diego, I confess that, even given this encouragement, I had much to learn and was somewhat daunted by the work ahead.

During the six months since our San Diego meeting, we've made good progress in re-establishing the Secretariat General Office and role. There's a great deal still to be done, both before our meeting in Saint Petersburg and after. And, although I've gained some of the understanding that's required, there's still much that I need to learn. Still and all, I'm encouraged by what we have been able to accomplish.

The accomplishments to date that I can report on begin with establishing new working relationships between members of the Executive Committee and the Secretariat General's Office. Although this was complicated, we've largely accomplished the task. We've focused on this because 1) the S-G role has been converted from a paid position to a volunteer position, and because it was necessary for me to also assume the responsibilities of your interim Treasurer. I'm particularly grateful to President Hiew, to President elect Consuelo Barreda-Hanson; to Parliamentarian O'Roark for their patience, wisdom and good will in this work.

More concretely, we've successfully obtained support from my university (UMA) here in Augusta. We've also transferred much, (not yet all) of the files and accounts, credit card machines and the like, to their new location in Maine. My particular thanks to Past Treasurer Goetz for making this work possible.

Turning to the responsibilities of the S-G's Office, I've first worked to support the conference organizing committee chaired by President Elect Barreda-Hanson. My second priority has been to familiarize myself with the management of ICP's finances, incorporation and tax status. Good progress has been made on both items and I will report in detail on them in Saint Petersburg.

The development of our July meeting, a difficult task in any year, has been particularly challenging due to a variety of factors. At the risk of giving you too much information, over and above the facts of the Board having adapted revised Bylaws and a large number of new leaders stepping forward, these atypical challenges have included: major fluctuations in currency exchange rates and travel costs; the need to adjust our plans after consulting with local members and potential site officials in Saint Petersburg; concurrent effort to upgrade ICP's communication methods (website etc.), and Russian visa requirements. Nevertheless, thanks to the efforts of our leaders and major efforts by Board Member Natasha Parnyuk and by Valerie Sitnikov, although it has taken time to organize, we expect to have an excellent conference.

The third and fourth S-G priorities during this six month period have been a) supporting the work of the Communications Committee; and b) working out the details for how we accomplish Council business between face to face meetings. This work is not completed yet but we have moved forward. Please refer to the current report from Richard Velayo, Chair of the Communications Committee, for details on this item. Richard and to Annie Crookes, our new IP Editor, have been dedicated and flexible efforts under difficult circumstances as we've been re-establishing the IP, the functions of the icpweb.org page, email protocols etc.

Looking Towards Enhanced Communication via our Website: A Communications Committee Update

Let me first thank the co-chair of our Communications Committee, Shay Mann, who despite working fulltime as a prison administrator, and writing his doctoral dissertation in Counseling Psychology at Virginia Commonwealth University, has still managed to create a state-of-the-art website for ICP (www.ICPweb.org) which was launched in the Spring of 2007. Our website was demonstrated at the 2007 ICP Conference in San Diego and was very well received. We continue to determine ways to create an even better website that promote and facilitate the kind of communication that is a more efficient and cost effective for its members, officers and board.

There are two major goals that this Committee aims to achieve by the end of the Spring. The first is to integrate a fully functioning online discussion forum (www.ICPweb.org/forum) that our members and board will be able to easily access via the ICP's website. What this electronic form of communication will allow us to do is to provide a central site in which relevant communications among members may be directed, organized, and archived. This will facilitate more efficient communication through threaded discussions organized into topics, so that one may easily post in a relevant discussion board or look through discussions made on topics that have been posted in the past. What I find to be most useful about this discussion forum is that the postings are organized by topic and because they are archived, one may easily trace back what have been discussed in the past without having to rely on having to sort through and look for past emails (which may or may not have already been deleted). In addition, I find the use of the discussion forum to be fairly intuitive. One who wishes to learn more about it, may simply click on a link called "Frequently Asked Questions" in the first posted discussion board called "About ICPwebConnect". Then again, you could always choose to email your inquiries via our expert webmaster Shay at mannsc@vcu.edu.

The second immediate major goal of the Committee is disseminate relevant and up-to-date information soon about the 66th Annual ICP Conference to be held on July 16-19, 2008 in St. Petersburg, Russia. We will be providing information regarding registration, programming, and feature highlights about interesting things to do in St. Petersburg. There is also a discussion board titled "ICP Conference - Saint Petersburg, Russia" on our Discussion Forum (www.ICPweb.org/forum) where you can post comments, suggestions, or inquiries.

In consultation with the Communications Committee members, I have outlined below a timeline to achieve specific goals for the Committee to accomplish between now and the ICP Conference in St. Petersburg. These are as follows.

Communications Committee Report Continued...

In the bylaws (Section 1.6, p. 7 February 16, 2005), there was only mention of the Publications Committee which states:

"The Publications Committee is headed by a Chair, appointed by the President, with approval by the Board, and consists of two additional members, editors of all publications, and the Treasurer and Secretary-General as ex-officio members. The Committee reviews expense and income statements, recommends policies on subscriptions, advertising, and schedules, and advises and assists the editors."

In the bylaws (Section 1.8, p. 8), Public Information (Media) Committee is described as follows: The Public Information (Media) Committee is responsible for the dissemination of information about the association and its members.

In the Policies document (Section 1.6, p. 18, February 16, 2005), I do not see any mention of the Communications Committee. Is it there somewhere? What I do see is a Publications Committee that mentions the following: *"The Chair of the Publications Committee serves for a term that does not have a specified period of time."* Thus, I presume that there should be a Communications Committee included in the next version of the bylaws.

At the bylaws proposal I received dated August 13, 2007, Article 11, which describes the Communications and Publications Committee as follows:

ARTICLE 11 COMMUNICATIONS AND PUBLICATIONS

ICP places a high value on communication, global networking and mutual support. The association uses all forms of telecommunications including the IP electronic newsletter, printed and e-mail, listserves, telephone, fax and other available means.

11.1. The International Psychologist (IP) is the official newsletter for the Council.

11.1.1 The Editor of the IP is appointed by the Board, for a renewable term of three years. The Editor with the Communication and Publications Committee publishes the IP at least three times per year.

11.1.2 Matters related to the preparation, publishing, and dissemination of the IP are approved by the Board, and set out in the Administrative Policies & Procedures.

11.2. The Membership Directory, with members' names, addresses, and professional data, is published at least annually in the IP or provided at the ICP website. The Board oversees matters related to the preparation, publishing, and dissemination of the Directory.

11.3. ICP's Annual Convention Proceedings are included in the IP.

11.3.1. The Editors of the Annual Convention Proceedings are appointed by the Board for a term determined by the Board and set out in the Administrative Policies & Procedures. The Editors are ex officio members of the Publications Committee. Matters related to the preparation, publishing, and dissemination of the Annual Convention Proceedings are approved by the Board.

11.4. The ICPWeb.org website is the official web site of the International Council of Psychologists. The Webmaster is appointed by the Board. The Web Master is a member of the Communications and Publications Committee. 11.4.1. The contributors to the website and to IP are determined by the Editor or Webmaster with the approval of the Board.

11.4.2. Matters related to the preparation, publishing, and use of material on the Web Site are approved by the Communications and Publications Committee and periodically reviewed by the Board.

Below are my recommendations:

1. Public Information Committee should be renamed as Communications Committee and assumes its functions.

2. The Communications Committee Chair be described in the Policies document as follows:

"The Chair of the Publications Committee serves for a term that does not have a specified period of time and is primarily responsible for helping disseminate information about the organization and helps determine feasible ways to facilitate communication among its members and board. High value is placed on communication, global networking, and mutual support."

3. The Communication Committee be described in the bylaws as follows:

"ICP's Communications Committee primarily helps disseminate information about the organization and helps determine feasible ways to facilitate communication among its members and board. It places a high value on communication, global networking, and mutual support. "

1.1 The Communications Committee works closely with the Webmaster in determining the organization's website design and content of the organization's website, and how such content may be effectively disseminated. Materials that are made available for dissemination are the organization's newsletter, materials and updates regarding meetings and events (including its annual convention), its membership directory, and other forms of relevant announcements. 1.1.1 The ICPWeb.org website is the official web site of the International Council of Psychologists. The Webmaster is appointed by the Board. The Web Master is a member of the Communications and Publications Committee. 1.1.2 The contributors to the website and to IP are determined by the Editor or Webmaster with the approval of the Board.

1.1.3 Matters related to the preparation, publishing, and use of material on the Web Site are approved by the Communications and Publications Committee and periodically reviewed by the Board.

1.2 The Communications Committee works closely with IP newsletter Editor in determining ways to distribute the publication.

1.2.1 The International Psychologist (IP) is the official newsletter for the Council.

1.2.2 The Editor of the IP is appointed by the Board, for a renewable term of three years. The Editor with the Communication and Publications Committee publishes the IP at least three times per year.

1.2.3 Matters related to the preparation, publishing, and dissemination of the IP are approved by the Board, and set out in the Administrative Policies & Procedures.

1.3 The Committee works closely with the Secretary-General and the association's elected officers in determing the materials to be disseminated and to help facilitate communication among and between members and the board.

1.4 ICP's Annual Convention Proceedings are included in the Website and the IP newsletter.

1.4.1 The Editors of the Annual Convention Proceedings are appointed by the Board for a term determined by the Board and set out in the Administrative Policies & Procedures. The Editors are ex officio members of the Publications Committee. Matters related to the preparation, publishing, and dissemination of the Annual Convention Proceedings are approved by the Board.

1.5 The Membership Directory, with members' names, addresses, and professional data, is published at least annually in the IP an made accessible via the ICP website. The Board oversees matters related to the preparation, publishing, and dissemination of the Directory.

Report of UN in Geneva: Spain and Switzerland Millennium Developmental Goals

The Millennium Development Goals (MDGs MD involve a Global Deal between rich and poor countries: poor countries pledged to reform policies, improve governance, and to channel resources. Rich countries, for their part, promised to deliver more and more effective aid, faster and deeper debt relief, and fairer trade rules. Previous UN reports published in International Psychologist were: Austria and Japan IP, 47, 1, p. 4), Germany and Italy (IP, 47, 2, p. 10), United States and Australia (IP, 47, 3, p. 6-7), Belgium and Canada (IP, 47, 4, p. 13-14). Spain and Switzerland are presented here and France and Portugal will be presented in the next issue.

WHAT ABOUT SPAIN?

Record on aid. Spanish official development assistance (ODA) represented only 0.32% of national income (GNI) in 2006. This means that Spain ranked in the bottom third of EU-15 countries on aid volume. Spain has made a commitment to achieve the 0.7% GNI target for ODA by 2012 and has set annual intermediate targets, including a target of

0.5% for 2008. The latest Master Plan for Spanish cooperation, covering the period 2005-2008, outlines the strategic orientation of Spanish aid over this four-year period. In addition, Spain could better reflect its commitment to country-led poverty reduction strategies by better integrating these into its own country strategies. Record on debt relief: Spain continues to provide development loans to poor countries including highly indebted poor countries (HIPCs). In particular, the OECD suggests that Spain take account of recipient debt sustainability and income levels in the allocation of it loans. Spain has strongly supported international efforts on multilateral debt relief and - in particular - has contributed to the Heavily Indebted Poor Country Initiative (HIPC) fund. Record on trade: As part of the European Union, Spain implements the European Union's common agricultural and trade policies. Support levels are slowly declining as a result of gradual reform of the Common Agricultural Policy. As part of the Doha "Development" Round trade negotiations at the World Trade Organisation in December 2005 in Hong Kong, the EU committed to eliminating export subsidies by 2013. While there are only a few exceptions to this free market access, three products which are important agricultural products for poor countries were excluded until 2009 in order to appease vested interests in the EU. Spain has always acted as a quiet supporter of the status quo on agricultural policy. Policy coherence for development Spain's overall commitment to development: Spain has integrated policy coherence for development into its legal framework, such that the principles and objectives of development cooperation must be reflected in all other policies affecting developing countries. Spanish Public Opinion: Public support for development cooperation appears to be strong. Spanish public opinion is favourable to efforts to help the world's poor. In a recent survey commissioned by Fundacion Carolina and implemented by the Centre of Sociological Research in 2005, it was found that, in terms of priorities, 77% thought that the eradication of poverty and hunger should be the first priority for action, and 47% thought that the respect for human rights should be the second priority.

WHAT ABOUT SWITZERLAND?

Record on aid: In 2006, Switzerland provided the equivalent of 0.39% of its national income (GNI) in official development assistance (ODA). Switzerland's willingness to consider more ambitious aid commitments and targets from 2008 onwards is very welcome. Switzerland has made poverty reduction a main objective of its foreign policy and considers the Millennium Development Goals and the Millennium Declaration to be important development policy milestones. Switzerland works closely with the donor community in elaborating policies, strategies and appropriate instruments for its international cooperation. It is committed to implementing the Rome and Paris Declarations on aid effectiveness and has made a credible start on the harmonization of procedures with other donors and the alignment of policies and procedures with those of recipients. Record on debt relief: In more recent years, Switzerland has relied upon multilateral initiatives for debt reduction, and has not taken any further bilateral measures. Indeed, Switzerland did not have much of a role in shaping more recent enhancements to the HIPC. Record on trade: Swiss trade policy belies Switzerland's demonstrated commitment to developing countries through its development cooperation. Swiss agricultural policy is particularly problematic. More recent policy changes include a decision to reduce tariff escalation in the food industry, and a decision to phase out milk quotas between 2006 and 2009. Switzerland is also gradually reducing both domestic and export subsidies in the agricultural sector, but they remain very high. Policy coherence for development and Switzerland's overall commitment to development: The OECD notes that the promotion of policy coherence across the Swiss Federal Administration, and efforts to ensure that the debate on development issues goes beyond the two aid-providing agencies, remains a challenge. The Centre for Global Development (CGD) ranks 21 of the world's richest countries based on their dedication to policies that benefit poor nations. CGD's "Commitment to Development Index" (CDI) looks at seven policy areas important to developing countries: aid, trade, investment, migration, environment, security and technology. Swiss public opinion. Surveys of Swiss public opinion tend to confirm the Swiss public's continuing interest in humanitarian aid and development cooperation, but there is room for raising awareness among policymakers, particularly on the links between world poverty, security and aid flows.

DEATH OF A GREAT CLINICIAN, ACADEMICIAN AND RESEARCHER: PADMAL de SILVA (1944-2007).

Padmal de Silva was born in Ceylon, Sri Lanka and he published his first novel at the age of 13. Padmal was a Senior Lecturer in Clinical Psychology at the Institute of Psychiatry, University of London, and Consultant Clinical Psychologist for the South London and Maudsley National Health Service Trust, London, UK. He was also a Senior Clinical Tutor of Clinical Psychology Doctoral Training Program at the Institute of Psychiatry, London. Though he had diversity of clinical and research interest, anxiety disorders, sexual and marital problems, and eating disorders were the major ones. He published numerous papers as a single author and also was coauthor with other renowned researchers and clinicians. His work with S. J. Rachman, of Obsessive - Compulsive Disorder - The Facts (1992, 1998) and Panic Disorder - The Facts (1996), both published by Oxford University Press are considered to be classical and worth mentioning here. His scholarly and professional contributions cover diverse areas of psychological theory and practice such as behavior therapy, cognitive psychology, cross-cultural psychology, sexual and marital therapy, obsessive compulsive disorders and post traumatic stress disorders. Besides being member of numerous scholarly bodies, he was a Fellow of the British Psychological Society.I was one among those who were privileged to be trained by him as a clinical psychologists.

Recently, I received an email from a friend and a fellow trainee of Padmal that he passed away during his sleep. The words stung my ears, and life suddenly seemed to stop. The gravity of finally losing my mentor was a heavy blow. He certainly deserved such a peaceful death. To me, the world of clinical psychology is diminished because this great man is gone. I got to know him in 1984 when I joined the Institute of Psychiatry, University of London, as a trainee clinical psychologist. Due to his command and expertise in clinical psychology, all trainees would aspire to be placed with him. Looking back, I find my self very lucky to have three clinical placements under his supervision which provided me unbelievably precious opportunity to learn clinical expertise from him. I could probably go on and on writing about his expertise and my own experience at the Institute of Psychiatry, which no doubt was enormously beneficial mainly because of his presence as a tutor and a supervisor, but I find words just insufficient to explain and express the way I feel. Padmal was a thorough professional, most sought and consulted at the Institute for his expertise when I joined as a trainee. Any professional and academic forum would be incomplete without Padmal and he was considered as the final authority in many areas of clinical psychology. He had a great impact on my academic and professional life. All my memories are revived, I think of the moments when in that cold callous weather of London, a gentle and kind man took me under his wings--and he often used to take me in his office--and provided me a unique opportunity of first hand knowledge about what it was like to be a clinical psychologist. As a struggling student, Padmal let me work with a lot of patience and guidance. Mr. De Silva set for me an example of what a caring, compassionate clinical psychologist can be. The road was not at all easier but he made this journey easier for me which enabled me to graduate as a proud trained clinical psychologist from Asia in 1988. Building relationships with psychiatric patients somehow made sense because of the patient contacts I observed Padmal making with his patients, to summarize he taught me the a b c of Clinical psychology in a very non conventional and interesting manner.

After having finished my training in UK and returning back to Pakistan as a young Clinical Psychologist, I brought Padmal with me as my role model in the profession. I still practice the therapeutic interventions I learnt under his supervision and mainly the disorders which he trained me in. May I say that even topic of my Ph.D project is an inspiration from his work. Despite being workaholic, he could find ways to build and invest constructively in others' life, including myself. That's how I began a relationship with him as a trainee, a student and it seems to be a very long since I formally left the Institute of Psychiatry, however, he never turned down my expectations till he died. The very thought that Padmal de Silva who had a credit of shaping my life as a professional clinical psychologist is no more there, makes my heart sinks.

As I look back on the path that has led me to becoming a clinical psychologist, I know that I am not unique in wondering if I made the right choice of "Clinical Psychology" and above all in third world was hard and demanded many sacrifices. "Padmal, I salute you that you made it true". You will never die; you will survive all over the world in form of your trainees, who would make you proud through disseminating what they acquired from you. May God rest your soul in utter peace in the Heaven.
